Re: Implementation of Share Depository for Shareholders

To: Shareholders of Lam Dong Water Supply and Sewerage Joint Stock Company (LAWACO)

Lam Dong Water Supply and Sewerage Joint Stock Company (“LAWACO”) respectfully informs shareholders regarding the depository of LDW shares as follows:

Based on the Securities Registration Certificate No. 17/2019/GCNCP-VSD dated April 9, 2019 issued by the Vietnam Securities Depository (now the Vietnam Securities Depository and Clearing Corporation - VSDC) for LDW shares, LAWACO informs shareholders to proactively carry out share depository procedures when needed.

1. **Applicable subjects:** Shareholders currently owning LDW shares of LAWACO who have not yet deposited them.
2. **Principles of implementation:**
 - Share depository is carried out at the request of shareholders.
 - Shareholders who have not deposited their shares are still recognized as owners according to regulations, and non-depository does not affect ownership rights.
 - When shareholders wish to trade, transfer, or use securities-related services, they may carry out depository procedures at securities companies that are members of VSDC.
 - LAWACO supports confirmation of share information upon shareholder request.
3. **Guidelines for depository:** Shareholders carry out the following basic steps:
 - Step 1: Open a securities trading/depository account at a securities company (if not already available).
 - Step 2: Submit depository documents as guided by the securities company, usually including: · Securities depository request form · Share ownership certificate · ID card/Passport for individuals · Legal documents for organizations · Power of attorney (if any)
